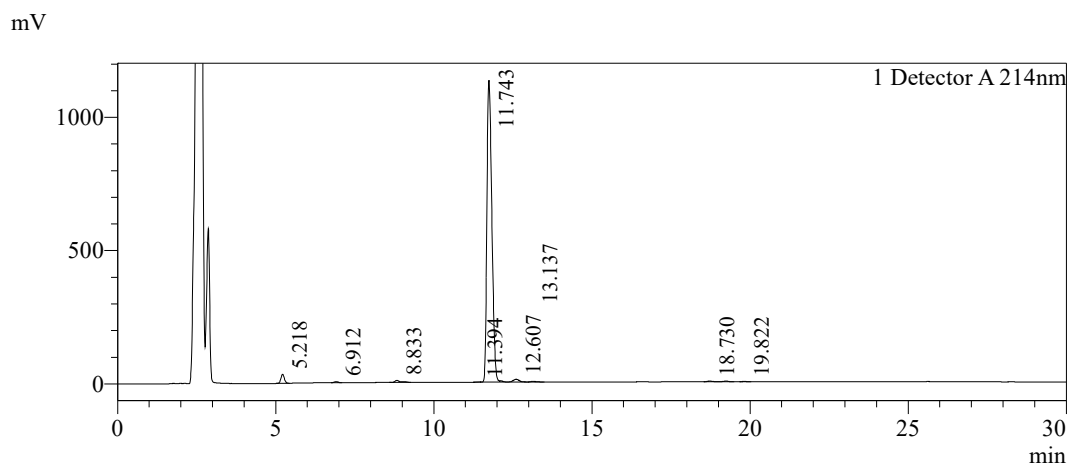

Chromatogram

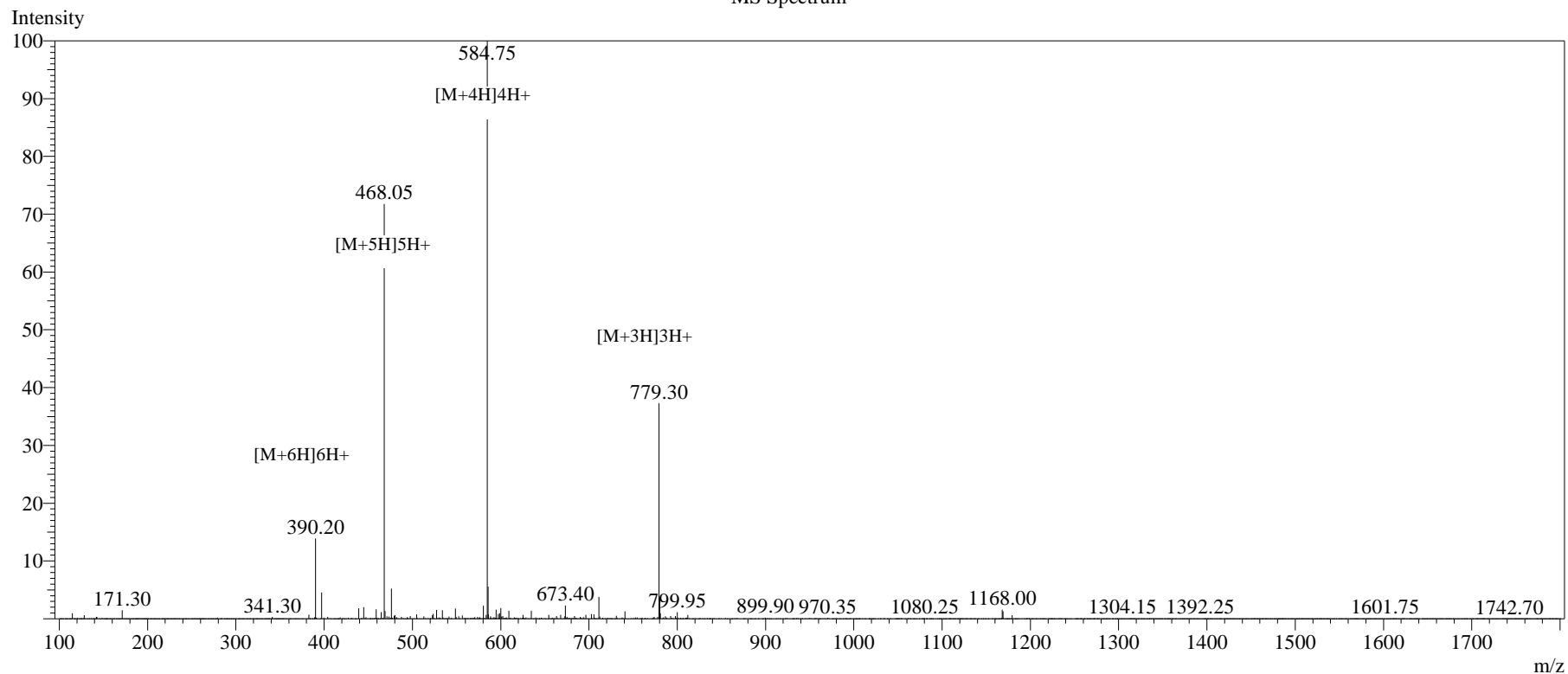
