


Fig1:; Western blot analysis of Phospho-PAK1(S144)+PAK2(S141)+PAK3(S139) on different lysates. Proteins were transferred to a PVDF membrane and blocked with 5% BSA in PBS for 1 hour at room temperature. The primary antibody (1/500) was used in 5% BSA at room temperature for 2 hours. Goat Anti-Rabbit IgG -HRP Secondary Antibody (HA1001) at 1:5,000 dilution was used for 1 hour at room temperature.; Positive control:; Lane 1: Hela cell lysate; Lane 2: NIH/3T3 cell lysate; Lane 2: SH-SY5Y cell lysate




Fig2:; ICC staining of Phospho-PAK1(S144)+PAK2(S141)+PAK3(S139) in Hela cells (green). Formalin fixed cells were permeabilized with 0.1% Triton X-100 in TBS for 10 minutes at room temperature and blocked with 1% Blocker BSA for 15 minutes at room temperature. Cells were probed with the primary antibody (1/50) for 1 hour at room temperature, washed with PBS. Alexa Fluor®488 Goat anti-Rabbit IgG was used as the secondary antibody at




Fig3:; ICC staining of Phospho-PAK1(S144)+PAK2(S141)+PAK3(S139) in NIH/3T3 cells (green). Formalin fixed cells were permeabilized with 0.1% Triton X-100 in TBS for 10 minutes at room temperature and blocked with 1% Blocker BSA for 15 minutes at room temperature. Cells were probed with the primary antibody (1/50) for 1 hour at room temperature, washed with PBS. Alexa Fluor®488 Goat anti-Rabbit IgG was used as the secondary antibody at 1/1,000 dilution. The nuclear counter stain is DAPI




Fig4:; Immunohistochemical analysis of paraffinembedded human liver carcinoma tissue using anti-Phospho-

polymer system. DAB was used as the chromogen. Tissues were counterstained with hematoxylin and mounted with DPX.




Fig5:; Immunohistochemical analysis of paraffinembedded human colon carcinoma tissue using anti-Phospho-





Fig6:; Immunohistochemical analysis of paraffinembedded mouse brain tissue using anti-Phospho-PAK1(S144)+PAK2(S141)+PAK3(S139) antibody. The section was pre-treated using heat mediated antigen retrieval with Tris-EDTA buffer (pH 8.0-8.4) for 20 minutes. The tissues were blocked

Fig7:; Flow cytometric analysis of Phospho-PAK1(S144)+PAK2(S141)+PAK3(S139) was done on NIH/3T3 cells. The cells were fixed, permeabilized and stained with the primary antibody (1/50) (red). After incubation of the primary antibody at room temperature for an hour, the cells were stained with a Alexa Fluor 488-conjugated Goat anti-Rabbit IgG Secondary antibody at 1/1000 dilution for 30 minutes. Unlabelled sample was used as a control (cells without incubation with primary antibody; black).
